The Independent Examiner position established in 2019, also undertakes promotion activities and is supported by the AusNCP secretariat.</p> <p>The AusNCP structure also includes a multistakeholder Governance and Advisory Board with members from the Australian Government, civil society, business and trade unions, with oversight, advisory and promotional responsibilities.</p>
